**NOTICE OF THE SECOND APPORTIONMENT FOR ASSESSMENT APPORTIONMENTS,
FISCAL YEAR 2014–15 BUDGET ACT**

The purpose of this letter is to notify you that an assessment apportionment payment has been made to your local educational agency (LEA). The assessment apportionment funds from the 2014–15 state General Fund may be used to pay approved apportionment costs from the 2013–14 and prior fiscal years for the California Assessment of Student Performance and Progress (CAASPP) System, the California English Language Development Test (CELDT), and the California High School Exit Examination (CAHSEE).

This assessment apportionment payment is made for the 2013–14 CAHSEE testing in accordance with criteria specified in California *Education Code* Section 1225(b) to reimburse LEAs for costs associated with the annual CAHSEE testing.

The State Controller will mail warrants to the appropriate county treasurers. Assessment apportionment funds are considered unrestricted and should be accounted for as Income Account or Revenue Object Code 8590 (Resource Code 0000) of the General Fund. The enclosed county listing provides the apportionment amount for LEAs.
