RESOLUTION NO. 2018-06

**CONSIDERATION OF JOHN ADAMS ACADEMY
CHARTER PETITION MATERIAL REVISION**

WHEREAS, the El Dorado County Office of Education (“EDCOE”) received a valid request to materially revise the John Adams Academy Charter Petition (“Petition” or “JAA”) approved by the El Dorado County Board of Education (“Board”) on or about February 28, 2017; and

WHEREAS, the Petition proposes to operate a site outside the Buckeye Union School District’s boundaries and inside Latrobe School District’s boundaries at 1102 Investment Blvd, El Dorado Hills, CA, 95762; and

WHEREAS, the proposed location is within the boundaries of the Latrobe School District, and the Petitioners provided notice to the Latrobe School District Superintendent, that the Petition proposed to operate a site at this location and notice was provided that a public hearing would be conducted regarding the potential change in location; and

WHEREAS, per Education Code Section 47605(b), the Board held a public hearing on the Petition at the Board’s April 13, 2018, meeting to consider the level of support for the Petition by teachers and other employees, and parents; and

WHEREAS, the approval and denial of a charter petition by a school district is governed by Education Code Section 47605; and

WHEREAS, the EDCOE’s Administration has reviewed the Petition, including its supporting exhibits, and prepared a Staff Recommendation on the Petition (attached as Exhibit A) for the Board’s consideration; and

WHEREAS, the Board has received, reviewed, and considered the Petition in its entirety, including its supporting exhibits, and the Staff Recommendation;

NOW, THEREFORE, BE IT RESOLVED that the El Dorado County Board of Education, having considered the Petition, including its supporting exhibits, the Staff Recommendation, and the level of support for the Petition by teachers, other employees, and parents, hereby adopts the recommendation and findings of the Staff Recommendation in their entirety as the findings of the Board, including the findings

that grounds do not exist to deny the Petition under Education Code Section 47605(b) or under the geographic restrictions to the Charter Schools Act (see Education Code Sections 47605(a)(5) and 47605.1(c), (d), and (g)); and

BE IT FURTHER RESOLVED that the Board specifically finds that JAA satisfies and will satisfy the requirements of Education Code Sections 47605(a)(5)(A) and 47605.1(d)(1) in that it is unable to locate a single suitable site within Buckeye Union School District's boundaries capable of housing the Petition's entire program, JAA provided advanced notice to the school district in which JAA proposes to operate a single site outside of the Buckeye School District's boundaries and JAA has committed to provide notice to the El Dorado County Superintendent of Schools and the State Superintendent of Public Instruction before it commences operations at this site if the Petition is approved.
